Important Information

1. ONLINE APPLICATION:

- a. Applications are invited from the eligible candidates possessing prescribed qualifications for various Technician posts mentioned in Schedule - I purely on contract basis. Please fill the application carefully. Any amendment / rectification / change / editing is NOT allowed in Name / Date of Birth / Post applied / Category etc. Applicants may note that no correspondence will be entertained in this regard.
- b. Name and number of posts, Essential qualification & Experience, Age limit & Category-wise distribution of posts are given in Schedule – I below.

2. ELIGIBILITY NORMS:

- a. **Cut-off date to determine the eligibility (other than upper age limit) is 24.02.2024 (Saturday).** To be eligible for selection for these posts, the candidate must have passed the qualifying degree examination & result should be declared to this effect on or before the last date of filling up of application form i.e **24.02.2024 (Saturday)**. Only such experience will be considered which is acquired after obtaining the qualifying degree/diploma, as applicable.
- b. Candidates who have been awarded degrees from foreign Universities / Medical Colleges should enclose "Equivalence Certificates" issued by the Association of Indian Universities, New Delhi / NMC, as applicable.
- c. It is the sole responsibility of the candidate to assess his / her own eligibility for the post for which he/she is applying in accordance with the prescribed qualification, experience etc. and submit his / her online application duly filled-in along with the desired information, documents and other supporting materials as per the advertisement. Suppression of factual information, supply of fake documents, providing false or misleading information or any other undesirable action by the candidate shall lead to cancellation of his candidature. In case, it is detected at any point of time in future even after appointment that the candidate was not eligible as per the prescribed qualification, experience etc. which could not be detected at the time of scrutiny / written / skill test and/or interview due to whatever circumstances, his / her appointment shall be liable to termination forthwith as per this clause and also based on his / her undertaking in online application form. Candidates are advised to confirm their eligibility prior to submission of online application.

3. CATEGORY CERTIFICATE:

- a. Candidates applying under OBC category must possess valid caste certificate. Since the vacancies are being advertised in financial year 2023-24, therefore, valid NCL-OBC certificate issued during the period from 01.04.2023 to 31.03.2024 will be considered valid. A candidate who submits NCL-OBC certificate issued before or after this period i.e. 01.04.2023 to 31.03.2024, his/her certificate will be considered as invalid and the candidature as OBC candidate will stand cancelled for this recruitment. Candidates **who are not having NCL-OBC certificate which has been issued during the period from 01.04.2023 to 31.03.2024** will not be considered against post reserved for OBC category under any circumstance.
- b. Candidates applying under EWS category must possess valid EWS certificate issued on or after 01 April, 2023. It must be in Hindi/English Language and valid for admission in Central Govt. Institution. As per guidelines, an EWS post is not carried forward or considered as backlog vacancy in case it remains unfilled, therefore candidates from other category may be allowed provisionally to apply for the said post subject to the condition that he/she will be considered for that post as a UR candidate only if EWS category seat is otherwise not filled.

4. RESERVATION:


- a. Reservation for SC, ST, OBC, EWS & PwBD has been provided in the posts in accordance with Rules.

- b. Reservation for Persons with Bench-mark Disabilities [PwBD] candidates having not less than 40% disability is 4% which will be provided on horizontal basis to Persons with Bench-mark Disabilities [PwBD] candidate in their respective categories. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions and countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

5. **APPLICATION FEE:** Rs 1000/- (Non-refundable) for General / OBC / EWS category candidates. Bank and payment gateway charges on the above amount will be borne by the applicant No fee for SC, ST & PwBD candidates. 6. **UPPER AGE LIMIT:**

- a. The upper age limit for applying these posts is **35 years** as on **01.01.2024 (Tuesday)**
b. Age relaxation will not be applicable to SC/ST/OBC candidates applying for UR posts
c. The maximum permissible age relaxations are:
i) SC/ST candidates: **5 years**
ii) OBC candidates: **3 years**
iii) Persons with Bench-mark Disabilities [PwBD] General Category: **10 years**
iv) Persons with Bench-mark Disabilities [PwBD] OBC Category: **13 years**

7. **GENERAL CONDITIONS:**

- a. AIIMS Jammu will not be responsible for any issue/delay in accessing information / updates by the candidate through the website.
c. No TA/DA will be paid for attending the written / skill test / document verification / personal interaction / joining the duty on selection etc.
d. The candidate may have to work in shifts and can be posted at any place/department of the Institute.



- e. The candidate should not have been convicted by any Court of Law.
- f. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the contract period.
- g. Candidates appointed will be purely on contract basis for one year or till regular posts sanctioned by MoHFW are filled up, whichever is earlier. Such candidates shall have no right to claim absorption, extension or permanent employment.
- h. The contract will automatically expire on completion of one year, if not terminated earlier by the Institute by giving one month's notice to the appointee. The appointee can also leave the Institute by giving 30 days' notice or salary in lieu of this notice period or for the period falling short of one month.
- i. The appointee shall be a whole-time employee of the Institute and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period.
- j. Competent Authority of AIIMS, Jammu reserves the right to:

8. DETERMINATION OF MERIT: The selection of candidate(s) will be based on written / skill test and/or interview. The written / skill test will carry 60 marks/MCQs pertaining to domain knowledge. All tie cases (more than one candidate having same marks in the cut-off of merit list of screening/skill test) will be resolved on the basis of date of birth. Older candidate (earlier date of birth) will be ranked above younger candidate. Executive Director & CEO reserves the right to ascertain the type of post(s) for which screening/skill and/or Interview test may be conducted.

9. SELECTION PROCEDURE:

- a. ***If a candidate wishes to apply for more than one post in different department/speciality, he/she is required to fill up application form separately and pay separate application fees, as applicable.***
- b. Based on the information provided by the candidates in the online application form, candidates are provisionally permitted to present themselves *in person* for appearing in the written / skill test without any scrutiny of eligibility or documents. Documents, to determine eligibility (w.r.t. to essential qualification(s), age, category, experience, wherever applicable, NOC etc.), of only those candidates will be scrutinized by the Institute's scrutiny committee who qualifies the written / skill test.
- c. The Institute reserves the right to ascertain the type of post(s) for which screening/skill test may be conducted. If the number of applications does not exceed 5 times the number of posts, the Institute may at its discretion select the candidates based on interview only.
- d. Candidates are required to report for the written / skill test and/or interview at 9.00 AM sharp. After 09.30 AM, the attendance will be closed and no candidate may be entertained.
- e. Candidates must bring original application form alongwith documents/certificates (along with **TWO** sets of self-attested Photocopies) of following documents for verification as and when required by the Institute as well as at the time of joining.
