However, on the day of interview, documents to determine eligibility w.r.t. to essential qualification(s), age, experience, as applicable, NOC etc. will be scrutinized by the Institute's scrutiny committee. **Only after the satisfaction of Scrutiny Committee w.r.t his/her eligibility, a candidate will be allowed to appear in the interview for the post. - 5. GENERAL CONDITIONS:**

7. **SELECTION PROCEDURE:**

- a. Candidates who wish to apply for more than one post should apply separately for each post, pay the applicable application fee for each such post.
